PROGRAM

The actual program will be "Friendship Canes" so those who are unfamiliar with this type group project will get an explanation. Additionally, an description of how "Purchase Awards" work will be a subject for a question and answer session. The carving and discussions should may cause some members to do a bit of multi-tasking since they may need to carve and listen at the same time. Hopefully it will not over tax anyone's brain in the process.

Pat has judged several shows in the Great Plains area and how won many awards including Best of Show. For those who don't know the Moores, they are from the Kindred, North Dakota, (near Fargo) and operate Moore Rough-

Out. If one needs reminding, Moore Rough-Outs has been a vender at our show for many years. Pat carves almost any style of wood carving and does it in an award winning style.

This should allow each carver to complete the piece, including the painting. Unfortunately for those who have not yet signed up, the full compliment of twelve have already enrolled. There is room for alternates in the event that someone will need to withdraw at the last minute.

For those who don't know Rusty, he has won many awards around the country and has one of his carvings featured in ChipChats in the CCA competition (page 63). In case you haven't noticed, he has won many, many blue ribbons at the OCWC show over the past few years.


Gary James led of the evening with two examples of flat plane carving and one whittled stick.



What is a Purchase Award?

Many of the Club members have expressed some confusion relating to the tradition of offering an opportunity to take part in "Purchase Awards" at the closing hours of our annual show. Members have two ways of taking part — as a purchaser or potential award winner.

The idea is to match those who would like to purchase a carving for a specific dollar amount with carvers who would like to surrender their carving for that amount. The awards range from fifty dollars (\$50.00) to several hundred. The carvers then are invited to place their carving on tables specified for their carvings' value. The one offering the award is then invited to select a carving from the appropriate table. The award amount is then given to the carver and the carving goes home with the purchaser. No carving may be placed on a table whose value is greater than the price offered during the show.

The order in which those offering the award are allowed to make their selection is in the order that their award was committed and the money was received. Should the one offering the award not find anything they would like to have on the table they may select from other tables; however, the total amount of the award must equal or exceed the original amount. If a more expensive selection is taken, the individual must pay the additional costs.

This is an excellent method of getting a superb carving at a bargain price. Last year several members took advantage of this. One such award is Lynn Doughty's carving selected by Richard Dalke (see page 2). Pete Zachry also got one of Lynn's carvings. In previous years Pete has won a prizewinning bird carving by Cliff Baker and several members have bird carvings from Neil Nulton. Many members have won the cash awards from those wanting their carvings. It is never too early to get your award in so you can have an early selection.
